FESTIVAL TIME AND PLACE

Youth Arts Festival 2023 will be located along 1st Street and on Greenville Town Common near the river.

SET UP: 8:00 - 9:30AM

(Vehicles must be out of festival load in area by 9:00AM.)

HOURS OF OPERATION: 10:00AM - 4:00PM

FOOD VENDOR LOCATION: On the Town Common side of

Ist Street

BREAKDOWN: Begins at 4:00PM

(Vehicles may not enter the festival load in area until 4:15PM.)

BOOTH SPACES

o A section of this one-day outdoor festival takes place on a paved surface which prohibits anchoring any supports into the ground.

o Please plan to have appropriate weights for your display, in the event of wind.

o Water sources are available, if noted on application, to vendor booths. Water sources could be up to 100-200 feet away.

o Electricity is available on a limited basis for an additional fee. o Vendors will be asked to keep all noise (including radios, background music, played instruments, etc.) at an absolute minimum in consideration of other artists and patrons.

o Please take note that this is an outdoor festival.

o Set-up must be professional in appearance. Participants must stay in place until the end of the festival. All units must be of sound construction and must not obstruct others.

EQUIPMENT

o Booth fees do NOT include tents, tables, or chairs.

Please, plan to bring your own.

- o Quiet generators are encouraged.
- o Plan to have appropriate weights for your display, in the event of wind.

2023 FOOD VENDOR APPLICATION RULES AND REGULATIONS

APPLICATIONS AND FEES

o Please note – All checks will be deposited upon receipt. The deposits of checks does not mean that you are accepted. Refund checks will be issued for those vendors not accepted for Youth Arts Festival 2023.

o Checks returned for insufficient funds are subject to a \$50 handling fee.

REFUND POLICY

o We understand that circumstances may require accepted Youth Arts Festival vendors to withdraw from the festival after being accepted. Vendors will be refunded their booth fees (minus a \$30 processing fee) if you notify Emerge Gallery & Art Center in writing by October 1, 2023. After this date, no refunds will be given. No exceptions.

SALES TAX

o Youth Arts Festival organizers receive no commission on sales. Each vendor is responsible for the collection of North Carolina sales tax during the festival. To apply for a Sales Tax and use a Tax Account Number visit www.dor.state.nc.us and choose form NC-BR. For additional information about North Carolina sales tax, please contact the NC Department of Revenue at 1-877-252-3052.

DIGITAL IMAGES

o All food vendors must include a photo of their booth space and three photos that highlight their food. mThese photos can be e-mailed to paula@emergegallery.com. These items could also be used for promotional materials.

RAINOUT PROCEDURE

o Youth Arts Festival is a rain or shine event! The committee will be working to secure an indoor rain location. In the event of inclement weather, the Youth Arts Festival Committee will consider the hazards and needs of festival participants before making any decision associated with canceling or suspending the festival. In such cases, festival officials will keep participants up to date with notifications and decisions in a timely manner. Should a vendor decide to pack up or leave prior to when the end of the festival has been declared, that vendor may jeopardize future participation in the Youth Arts Festival.

ENFORCEMENT

o Food vendors are required to complete a Health Department application and return with a festival application and a menu. Vendors must pass inspection by the Health Department.

o Vendors will be placed along the Greenville Town Common side of 1st Street.

o Vendors are required to submit a complete list of every food item and the price that will be charged for each. Include ONLY items that you plan to sell at the Youth Arts Festival. o Menu/price list of sale items must be posted (a minimum size of 18"x 24") on the front of the concession listing the prices of all items being sold. Vendors will not be allowed to deviate from the menus submitted to Youth Arts Festival Committee.

o All vendor signage MUST stay within their booth space. Placing advertisement signage outside of booth space at the festival is prohibitied.

o Vendor locations are determined by the Youth Arts Festival Committee.

o Vendors must remain in place until the end of the festival. o Space assignments, parking information, etc., will be emailed to vendors by September 30, 2023.

o Fees are refundable (minus a \$30 processing fee) if a written cancellation notice is received by October 1, 2023. No exceptions!

o Make checks payable to "Emerge" for BOOTH FEES and "Pitt County Health Department" for your TEMPORARY FOOD PERMIT.

o It is required that food being sold at the Youth Arts Festival follow Youth Arts Festival guidelines and be consistent with the menu submitted by the vendor. The Youth Arts Festival Committee, the City of Greenville, and Emerge Gallery & Art Center reserves the right to revoke the sale of any food item in question from the event, as well as the vendor if Youth Arts Festival directions and policies are not followed. The removal of a vendor would result in the forfeit of all fees and future participation may be refused.
